Federal law prohibits buying controlled substances such as narcotic pain relievers (e.g., OxyContin, Vicodin), sedatives (e.g., Valium, Xanax, Ambien), stimulants (e.g., phentermine, phendimetrazine, Adderall, Ritalin) and anabolic steroids.
